

## **Demand Works Smoothie EULA**

This End-User License Agreement (“EULA”) is a legal agreement between Licensee (either an individual or a single entity) and Demand Works Company (“Licensor”), which covers your use of Demand Works Smoothie and related software components (“Software”).

If you do not agree to all of the terms of this EULA, then you should not download, install or use the Software. If you already downloaded or installed the Software, you should remove the Software from your system and destroy all copies.

### I. Definitions

- "Licensor" means Demand Works Company.
- "Licensee" means an individual or a legal entity exercising rights under, and complying with all of the terms and conditions of this EULA or a future version of this EULA.
- "Software" means software program known as Demand Works Smoothie in binary form, including its documentation, any third party software programs that are owned and licensed by parties other than Licensor and that either integrated with or made part of Software (collectively, "Third Party Software").
- "License Certificate" means evidence of a license provided by Licensor to Licensee in electronic or printed form, and defines the optional rights related to the Software.
- "License Key" means a unique key-code file, provided by Licensor or its authorized representatives, that enables the Licensee to use the Software.
- “User” is a licensed user of the Software. A user is a person and not a group of people. User licenses are transferable to other users.
- “Server” is a production server. If a server is licensed, Licensee may reproduce the software for testing and/or backup purposes.

### II. Ownership

The Software is the property of Licensor or its suppliers. The Software is licensed, not sold. Title and copyrights to the Software, in whole and in part and all copies thereof, and all modifications, enhancements, derivatives and other alterations of the Software regardless of who made any modifications, if any, are, and will remain, the sole and exclusive property of Licensor.

### III. Grant of License

According to the License Certificate, Licensor grants Licensee a non-exclusive, non-transferable license to use the Software under certain obligations and limited rights as set forth in this EULA:

Licensee may:

- Use each License Key on more than one computer system, as long as it is always used by the same user. Each additional user of the Software requires an additional License Key even if the software is installed on only one computer.
- Make copies of the Software and the License Key as reasonably necessary for the use authorized by this EULA, including as needed for backup and/or archival purposes. No other copies may be made. Each copy must reproduce all copyright and other proprietary rights

notices on or in the Software Product.

#### IV. License Restrictions

Licensee may not:

- Reverse engineer, decompile, disassemble, modify, translate, make any attempt to discover the source code of the Software in whole or in part.
- Distribute, copy, publish, assign, sell, bargain, convey, transfer, pledge, lease or grant any further rights to use the Software.
- Modify or create derivative work based Software in whole or in part.
- Tamper with, alter, disable or circumvent the Software's built-in license verification and enforcement capabilities.
- Remove or alter any trademark, copyright, logo or other proprietary notices in the Software.
- Disclose the License Key in any way.

#### V. Limited Warranty

Licensor warrants that the Software will not infringe the copyright of any third party. In the event that the Software becomes, or in Licensor's opinion is likely to become, the subject of a claim of copyright infringement, Licensor at its option may (1) secure for Licensee the right to continue using the Software, (2) replace or modify the Software to make the Software non-infringing, or (3) refund the payment for the Software upon return of the Software and its associated documentation, with no further liability of any type or kind on the part of Licensor. The foregoing is Licensee's sole remedy for any such infringement claim.

Licensor does not warrant that the functions contained in the Software will meet Licensee's requirements or that the operation of the Software will be error free. Licensor warrants that, during the first ninety (90) days following delivery of the Software, the Software as delivered by Licensor will perform substantially in accordance with the reference manuals supplied with the Software. Licensor's sole obligation and liability under this section shall be at Licensor's option to replace or correct the Software so that it substantially conforms to the reference materials, or to refund the payment for the Software upon return of the Software and associated documentation.

Any modification of the Software by any person other than Licensor, or any use of the Software with infringing software or data will void Licensor's affirmative duties under the warranty provision. Licensor is not liable for any damage caused by running the Software.

Unless specified in this EULA, all express or implied conditions, representations and warranties, including any implied warranty of merchantability or fitness for a particular purpose are disclaimed, except to the extent that these disclaimers are held to be legally invalid.

#### VI. Upgrades and Support

Software Maintenance including telephone and email product assistance and software updates is available from Demand Works. One year of maintenance is required at the time of purchase for all license types except for the Learning Edition. Maintenance is payable on the Effective Date and at the beginning of each year thereafter. Maintenance fees will not be changed unless additional licenses are purchased, and the Maintenance term will extend automatically by 12 months on each anniversary

unless specifically cancelled by Licensee 30-days prior to the anniversary of the Effective Date. Maintenance does not include training or integration consulting services, which are available from Demand Works on a fee basis. Maintenance is not available for the Learning Edition, as it is not intended for commercial use.

#### VII. Limitation of Liability

To the extent not prohibited by law, in no event will Licensor (or any third-party-developer) be liable for any lost revenue, profit or data, or for special, indirect, consequential, incidental or punitive damages, however caused regardless of the theory of liability, arising out of or related to the use of or inability to use Software, even if Licensor has been advised of the possibility of such damages.

In no event will Licensor's liability to Licensee, whether in contract, tort (including negligence), or otherwise, exceed the amount paid by Licensee for Software under this EULA. The foregoing limitations will apply even if the above stated warranty fails of its essential purpose. Some states do not allow the exclusion of incidental or consequential damages, so some of the terms above may not be applicable to Licensee.

#### VIII. Term and Termination

This EULA is effective until terminated. Licensee may terminate this EULA at any time by contacting Demand Works and destroying all copies of Software. This EULA will terminate immediately without notice from Licensor if Licensee fails to comply with any provision of this EULA. Upon termination, Licensee must destroy all copies of Software. Licensee agrees that upon termination of this EULA for any reason, Licensor may take actions so that Software no longer operates.

Licensee may terminate Maintenance as provided in Section IV, and such termination does not imply termination of the Software License, however such Maintenance termination will void any and all warranties including those described in Section V, above.

#### IX. Governing Law and Severability

This EULA will be governed by and construed according to the laws of Pennsylvania, United States, without regard to that body of law controlling conflicts of laws. If any provision of this EULA is illegal or unenforceable, it will be deemed stricken from the Agreement and the remaining provisions of the Agreement will remain in full force and effect.

#### X. Integration

This EULA, including License Certificate, is the entire agreement between Licensee and Licensor relating to its subject matter. It supersedes all prior or contemporaneous oral or written communications, proposals, representations and warranties and prevails over any conflicting or additional terms of any quote, order, acknowledgment, or other communication between the parties relating to its subject matter during the term of this EULA. No modification of this EULA will be binding, unless in writing and signed by an authorized representative of each party.

#### XI. Reservation of Rights

All rights not expressly granted in this EULA are reserved by Licensor.
